Mayor Juan Villalpando called the meeting to order at 7:01 p.m., followed by the flag salute.

Council Member Julia Schooler made a motion to approve the Agenda as amended. Council Member Debby Kooy seconded. Motion passed 5-0.

Council Member Julia Schooler made a motion to approve the Consent Agenda and approval of vouchers #19192 in the amount of \$137.47; vouchers #19194-19231 in the amount of \$76,792.38 and electronic checks in the amount of \$29,253.99. Council Member Patty Neff seconded. Motion passed 5-0.

City Planner Alex Kovach updated the Council on the 2025 Comp Plan Amendments drafts. He has set a Public Hearing Date for public review on July 21, 2025 at 3:00 p.m. at City Hall.

City Engineer Jamin Ankney presented to Council the Water System Plan Amendment draft. The City Council authorized submission to DOH. The formal presentation, public comment, and adoption will be scheduled for a council meeting later this year

City Engineer Jamin Ankney updated Council on the Well 3 Test Well drilling. The project was open for bids on June 10, 2025 at 11:00 a.m. and received no bids. Engineering will reach out to The Public Works Boards Project Manager for further guidance on bidding requirements.

City Engineer Michael Woodkey presented to Council a map with different options to choose from for the alignment of the Park Pathway Project. Council discussion took place. Council directed Engineers to keep the pathway South of the trees.

City Clerk Amy Grace presented Resolution 2025-338 A Resolution adopting the Six Year Transportation Improvement Program for the period 2026 to 2031.

Council Member Debby Kooy made a motion to authorize the Mayor to sign Resolution 2025-338 A Resolution adopting the Six Year Transportation Improvement Program for the period 2026 to 2031. Council Member Patty Neff seconded. Motion passed 5-0.

City Clerk Amy Grace presented to Council regarding Ordinance 2025-02 Amending portions of GMC Chapter 12.04 and 12.08 regarding past due charges for Utility Bills. Council discussion followed.

Council Member Julia Schooler made a motion to approve Ordinance 2025-02. Patty Neff seconded. Motion passed 5-0.

City Deputy Clerk Ana Rodriguez presented to Council multiple online bill pay options for considerations.

Council Member Julia Schooler made a motion to direct the Mayor to negotiate and enter into an agreement with Xpress Bill Pay for online payment software for utility billings. Patty Neff seconded. Motion passed 5-0.

Council Comments: Debby Kooy spoke about the 4<sup>th</sup> of July Celebration and encourages everyone to come out.

Angel Diaz asked the Council what time the fireworks need to be stopped.

Attorney Kait Schilling announced she is leaving Ogden Murphy Wallace and will be working to transition the role of City Attorney to Heidi Greenwood and Emily Romanenko. Kait introduced Heidi Greenwood from Ogden Murphy Wallace who attended the meeting.
